The City of Pharr has called this meeting as allowed pursuant to Texas law, city charter, and Ordinance O-2015-28. The governing body may recess from day to day when it does not complete consideration of a particularly long subject as authorized by law. All persons desiring to address the governing body must register with the presiding city clerk prior to the scheduled meeting.

If during the course of the meeting, the PLANNING & ZONING COMMISSION should determine that a closed, or executive session of the COMMISSION is required, then such closed or executive session or meeting is authorized by Sections 551.071 et seq. of the Texas Government Code. Notice of closed or executive session will be given after the commencement of the meeting covered by this notice.

Should any final action, decision, or vote be required in the opinion of the Commission with regard to any item during the meeting, then such final action, final decision, or final vote shall be made during the open meeting covered by this notice upon the reconvening of the public meeting.

In compliance with Section 551.041 et seq. of the Texas Government Codes, VTCS (Open Meetings Act), notice is given that the Planning & Zoning Commission will meet to consider and act upon the following:

PRESIDING:

A. CALL TO ORDER:

- 1) Roll call and possible action on the excusing of any absent member of the Commission.

B. APPROVAL OF MINUTES:

1) Minutes of April 23, 2018

C. PUBLIC COMMENTS: *(Ordinance No. O-2015-28) A registered speaker may speak on several items or topics of public concern; however, a speaker may not exceed three (3) minutes as a whole when addressing the board. A registered speaker may not donate time to another speaker. No more than five (5) registered persons may speak at a scheduled meeting. A sign-in form must be filled out prior to the meeting to allow the registered speaker to address the governing body.*

D. PUBLIC HEARING: *(Ordinance No. O-2015-28). A registered speaker during the public hearing may not exceed three (3) minutes when addressing the board. A sign-in form for participation in public a hearing shall be promulgated by the city clerk and be made available at the city clerk's office. The public hearing sign-in form shall include the person or entity's name, address, telephone number, other contact information, organization if applicable, and other notices, authorizations, and acknowledgements as may be allowed by law from time to time. No registered speaker may be allowed to address the governing body once the public hearing has closed.*

1) Materiales Cantu LLC, owners, has filed with the Planning and Zoning Commission a request for a change of zone from Heavy Commercial District (H-C) to Limited Industrial District (L-I). The subject site is located on the east side of South Cage Boulevard with a physically address of 7803 South Cage Boulevard. The property consists of one (1) tract of land legally described as being all of Lot 1, Materiales Cantu Subdivision, Pharr, Hidalgo County, Texas. **COZ# 180421**

2) Michael R. Fryman has filed with the Planning and Zoning Commission a request for a Life-of-the-Use Conditional Use Permit to allow an Oversized Storage Unit (larger than 120 square feet) in a Single-Family Residential District (R-1). The property is legally described as being all of Lot 31, Block 2, Sandoval Subdivision Unit 2, Pharr, Hidalgo County, Texas. The property's physical address is 1711 North Date Street. **CUP#180422**

3) Marco Antonio Cortez, representing Iglesia Embajadores de Cristo (Restaurando la Unidad Familiar), has filed with the Planning and Zoning Commission a request for a Life-of-the-Use Conditional Use Permit to allow a church in a Heavy Commercial District (H-C). The property is legally described as being all of Lot 1, Esparza Subdivision, Pharr, Hidalgo County, Texas. The property's physical address is 5706 South Cage Boulevard. **CUP#180423**

4) Vanessa Ann Zuniga has filed with the Planning and Zoning Commission a request for a Conditional Use Permit to allow a Home Occupation (Massage Therapy Business) in a Single-Family Residential District (R-1). The property is legally described as being all of Lots 15 & 16, Lone Star Subdivision, Pharr, Hidalgo County, Texas. The property's physical address is 405 West Eller Avenue. **CUP#180424**

5) Polar Fast Trucking, LLC has filed with the Planning and Zoning Commission a request for a change of zone from Agricultural and/or Open Space District (A-O) to Limited Industrial District (L-I). The subject site is located on the west side of the 2800 Block of South Cage Boulevard. The property consists of two (2) tracts which total 4.657 acres, more or less, out of Lot 236, Kelly-Pharr Tract, Pharr, Hidalgo County, Texas. **COZ# 180426**

E. PLATS:

1) H.L.G. Plan Review Services, representing Oscar Lozano and Rosie Lozano, owner's, are requesting preliminary and final plat approval of the proposed Bautista Estates Subdivision Lots 1 & 2. The property is legally described as being a 1.848 acre tract of land out of Lot 36, Sing's Subdivision, Pharr, Hidalgo County, Texas. The property is located within the 600 Block of W. Corpus Street. **SUB#180207**

2) Sam Engineering & Surveying Inc., representing Ramon Guajardo Jr., owner, is requesting preliminary plat approval of the proposed Ferguson Subdivision. The property is legally described as being a 1.00 acre tract of land out of Lot 147, Kelly-Pharr Subdivision, Pharr, Hidalgo County, Texas. The property is located within the 400 Block of E. Ferguson Ave. (F.M. 495). **SUB#170511**

G. CLOSED SESSION: *In accordance with Chapter 551 of the Texas Gov't. Code, the Planning and Zoning Commission hereby gives notice that it may meet in a closed (non-public) executive session to discuss the items listed on the public portion of the meeting agenda.*

Pursuant to Section 551.071, the Commission may convene in a closed, non-public meeting with its attorney and discuss any matters related to **legal advice on pending or contemplated litigation, settlement offer, and/or on a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with this chapter.** The City and its attorney may also discuss such issues with the appropriate staff so as to obtain necessary and relevant information so that such discussion is informative and developed.

Pursuant to Section 551.072, the Commission may convene in a closed, non-public meeting to discuss any matters related to real property and deliberate the purchase, exchange, lease, or value of **real property as such would be detrimental to negotiations between the City and a third party in an open meeting.** The City and its attorney may also discuss such issues with the appropriate staff so as to obtain necessary and relevant information so that such discussion is informative and developed.

Pursuant to Section 551.074, the Commission may convene in a closed, non-public meeting to discuss any matters related to **appointment, employment, evaluation, reassignment, duties and discipline or dismissal of a public officer or employee and to hear any complaints or charges against an officer or employee.** The City and its attorney may also discuss such issues with the appropriate staff including members so as to obtain necessary and relevant information so that such discussion is informative and developed.

Pursuant to Section 551.076, the Commission may convene in a closed, non-public meeting to discuss any matters on the **deployment, or specific occasions for implementation, of security personnel or devices.** The City and its attorney may also discuss such issues with the appropriate staff so as to obtain necessary and relevant information so that such discussion is informative and developed.

Pursuant to Section 551.084, the Commission may convene in a closed, non-public meeting to discuss any matters involving an **investigation and may exclude a witness from hearing during the examination of another witness in the investigation.** The City and its attorney may also discuss such issues with the appropriate staff so as to obtain necessary and relevant information so that such discussion is informative and developed.

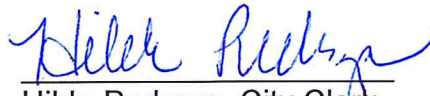
