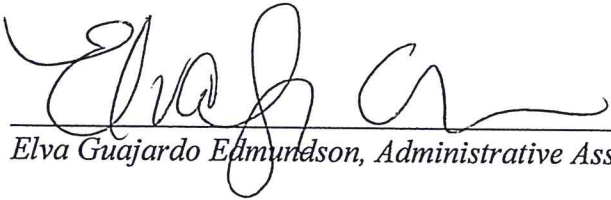
ITEM G: ADJOURNMENT
