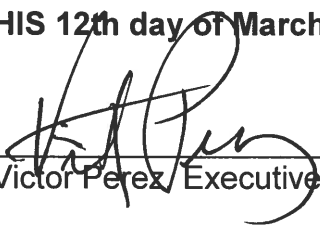

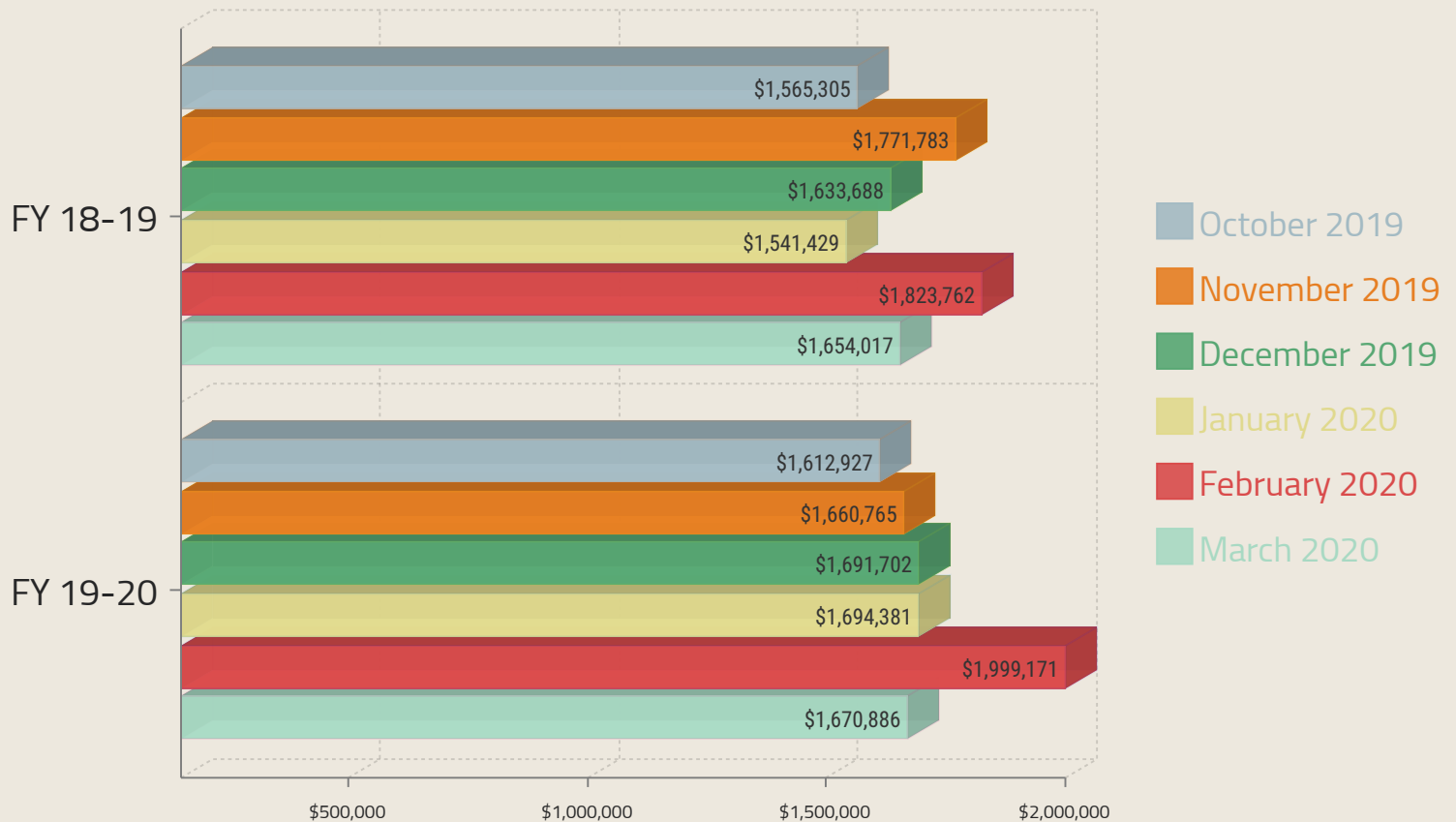

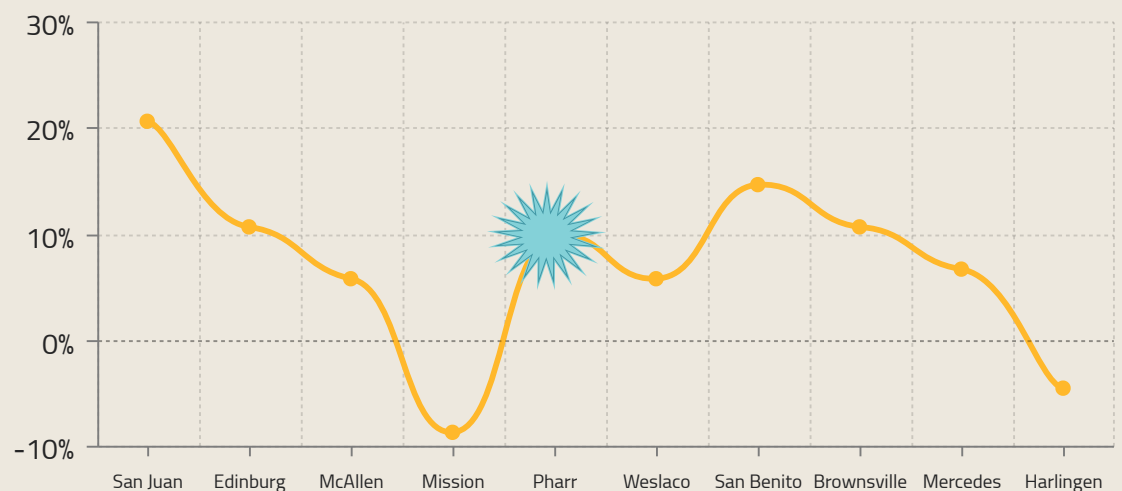
Sales Taxes Collection Snapshot-March 2020
