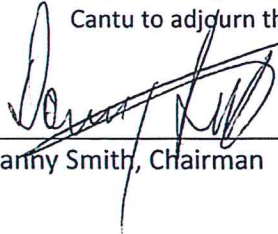
There were no comments from the public.

4. **1st Public Hearing:** For citizen participation on the development of the Action Plan 2018 and Notice of Availability for Program Year 2018.

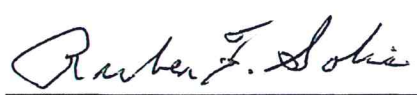
