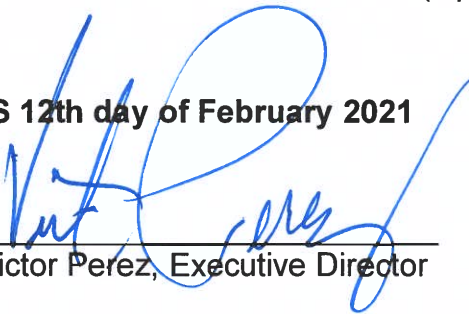

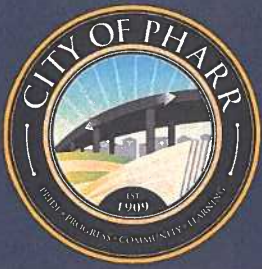

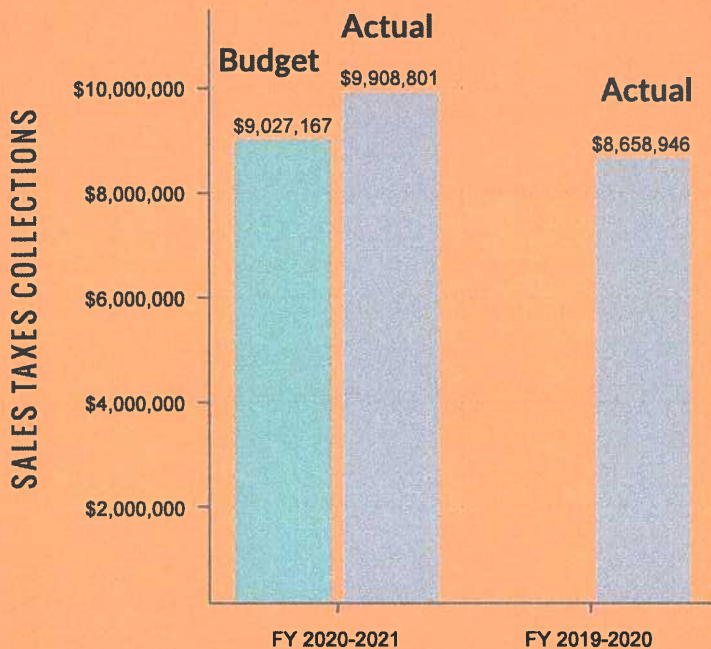

February 2021 FY 2020-2021



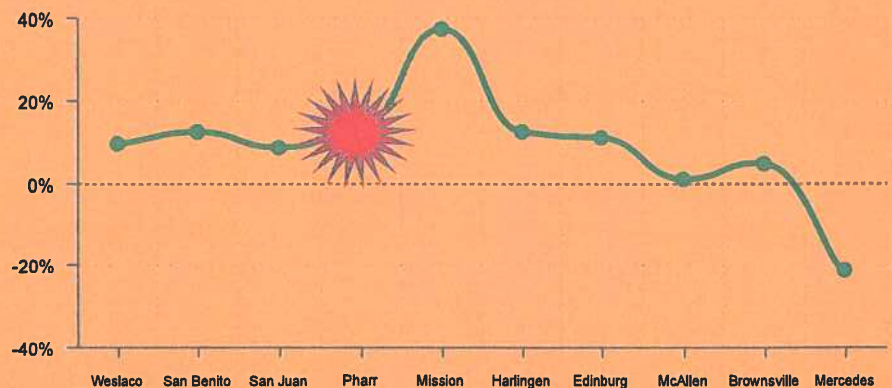
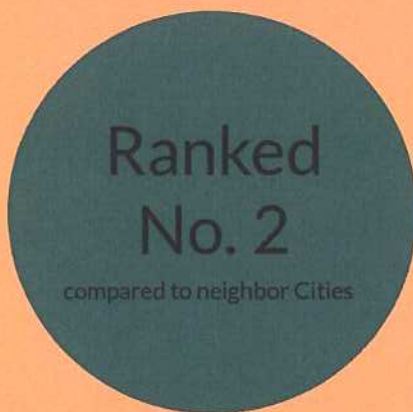
