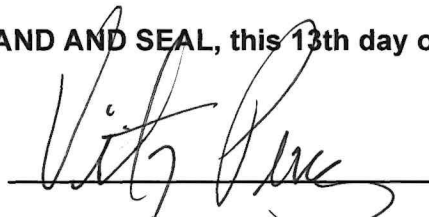

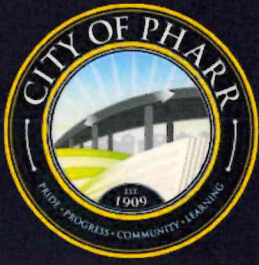

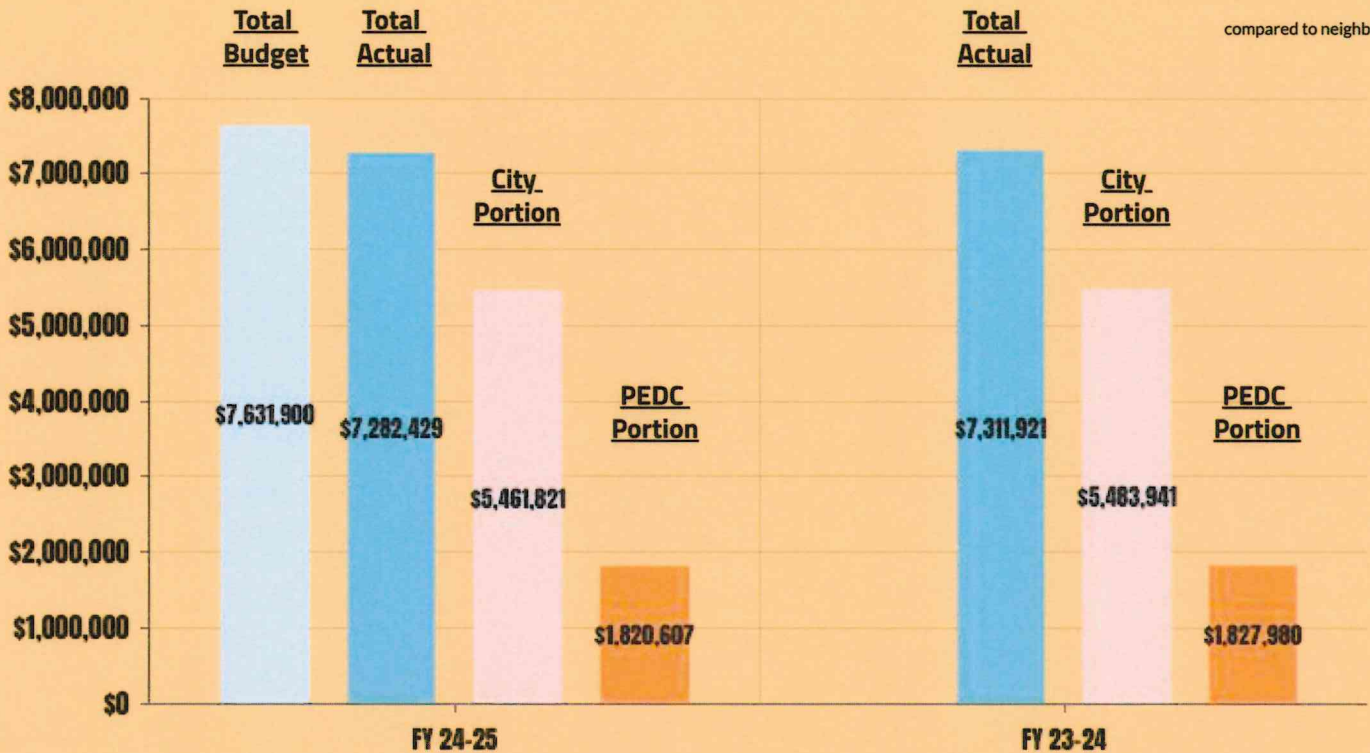
CITY OF PHARR SALES TAXES

compared to neighbor Cities



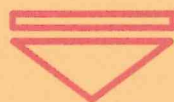
