

Karina Lopez, Economic Development Manager, informed the Board about the upcoming PEDC II events. She stated that through our ongoing programming we are now hosting the second cohort of the Kauffman Fastrac program applications are now open to the public and the program would be starting May 7 to June 18, 2025.

Karina Lopez, Economic Development Manager, stated that this year the PEDC would be partnering with UTRGV to participate in RGV Startup Week, a week-long event focused on supporting entrepreneurs and small business across the RGV. This event would bring together entrepreneurs, innovators, and leaders. She stated the event would take place May 1, 2025, at the Pharr Global Business Hub followed by an evening mixer at the PEDC backyard.

Karina Lopez, Economic Development Manager, further stated that Pharr EDC would partner with Texas Manufacturing Assistance Center (TMAC) to offer a free informational session for employers, focusing on providing businesses with the tools needed to strengthen and future-proof their workforce. This event took place at the Pharr Hub May 8, 2025.

Karina Lopez, Economic Development Manager, stated that Pharr EDC joined the city departments on the City Hall on Call community event to enhance engagement and provide information and resources from both the EDC and EDC Foundation. The event took place at the Pepe Salinas Event Center, May 13, 2025.

Karina Lopez, Economic Development Manager, invited the board to our Pharr EDC Foundation Scholarship Awards Ceremony May 14, 2025, at the Regency Hall in Pharr. She stated these scholarships are designed to support students in continuing their post-secondary education as they pursue their academic and career goals.

Karina Lopez, Economic Development Manager, further invited the board to the COMCE Zacatecas 2025 Commercial Mission event at the Forum Regency Hall May 15-16, 2025. She stated that the Pharr EDC hosted the COMCE Zacatecas 2025 Commercial Mission an international two-day event focused on produce and industrial development a comprehensive program feature participation from key agencies, including the Food & Drug Administration (FDA), Customs and Border Protection (CBP), UTRGV, Pharr International Bridge (PBI) and the Mexican Consulate.
